## **Position Summary**

This position serves as one of three AVA Member representatives on the independent Nominations Committee. These members bring a veterinary profession perspective to Board candidate evaluation, ensuring Board nominees align with the strategic needs and values of the AVA. This role is a volunteer advisory position and does not have decision-making responsibilities.

## **Key Responsibilities**

- Review director candidates for the AVA Board, after an expression of interest process.
- Assess all director candidates for the AVA Board in line with the Board Skills Matrix and Director position descriptions.
- Provide insights into professional veterinary standards, AVA member perspectives, and sectoral needs.
- Review and suggest updates to the AVA Board Skills Matrix for review by AVA Nominations and Governance Committee.
- Uphold a transparent and skills-based approach to director nominations.
- Adhere to AVA Code of Conduct, conflict of interest and confidentiality obligations.
- Communicate with specific SIG Executive Committees regarding Sector-Director nominations as required.

 Support the preparation of Board nominee recommendations to the AVA Board via the Nominations and Governance Committee.

### **Essential Criteria**

- Experience in board governance, leadership and recruitment of professional roles.
- Understanding of strategic issues and skills relevant to the AVA and the veterinary profession.
- Familiarity with governance structures and board responsibilities.
- Experience in recruitment, selection and performance review processes.
- AVA member who is a veterinarian.

#### Desirable Criteria

- Completion of formal, recognised governance training (e.g. AICD, Governance Institute)
- Breadth of veterinary experience (regional, sectoral, clinical/non-clinical, etc.)

#### Personal Attributes

- Commitment to AVA's mission, values, and goals.
- High standards of integrity, confidentiality, and professional conduct
- Strategic mindset and analytical capability in evaluating complex information.
- Sound judgment, discretion, and commitment to fairness in evaluating nominees.
- Proactive and engaged approach to committee responsibilities.
- Dedication of time and effort to fulfill the duties of a committee member.
- Ability to work collaboratively and constructively in a small team with diverse stakeholders.
- Excellent communication and presentation skills
